4.7 Subsidy Policy

Policy No. 4.7 (replacing previous policies 4.7, 4.8, 4.9 and 4.10)

In the interest of supporting the membership of Point Leo SLSC to participate in lifesaving related activities, subsidies are offered for the following purposes:

- Lifesaving and leadership courses and conferences
- Advanced lifesaving award courses
- Craft Subsidy: Members purchasing new or used Racing Mal or Surf Skis for competition.
- Interstate Championship competition participation
- State or National surf lifesaving teams

This policy outlines (a) the sub-committees responsible for the distribution of the subsidies and the review of the subsidy policy, (b) how the subsidies will be funded and managed within the Point Leo SLSC budget, (c) what activities included and excluded in each subsidy category, (d) the criteria for each subsidy category, and (e) the application and approval process for the subsidies.

The Subsidy Distribution Sub-Committee (SDSC)

The Point Leo SLSC Subsidy Distribution Sub-Committee will be annually appointed by the Committee, and comprise at a minimum:

- The Club Captain
- The Senior Team Manager
- The Treasurer
- The Vice President of Member Development
- The Chief Instructor, and
- Either the Vice President of Grants or the Vice President of Fundraising and Sponsorship (based on availability)

The Vice President of Grants or Vice President Fundraising and Sponsorship shall serve as Chair.

To ensure transparency and equity each section lead on the SDSC is required to work with other relevant Club members to review nominations and make recommendations to the SDSC on eligibility and compliance with expected behaviours.

For example, the Chief Instructor must collect input from the club trainers and assessors, and the Senior Team Manager must collect input from the Head Coach, Coaching Panel and/or Boat Captain.

As per clause 18.4 of the Club Constitution, the Subsidy Distribution Sub-Committee may co-opt any person with appropriate experience or expertise to assist the Sub-Committee in respect of such matters and on such terms as the Sub-Committee thinks fit. Any person so co-opted shall not be a Sub-Committee Member and shall not exercise the rights of a Sub-Committee Member but shall act in an advisory role only.

The Club Committee can initiate a review of the Subsidy Policy with appropriate representation. Any policy changes must be submitted to the Committee for review and approval in coordination with the Club budget process timeline in order to allow approvals prior to the annual budget preparation.

The Budget Management of Club Subsidies

All subsidies are in the absolute discretion of the Point Leo SLSC Committee and are subject to funds being available.

From time to time the SDSC may recommend to the Point Leo SLSC Committee that additional support than what is available in the annual budget or approved caps be provided to members in any of the subsidy categories. The Chair must specify the reasons for this request.

Inclusions and Exclusions in Club Subsidy Categories

Subsidies, including events and amounts to be subsidised, are determined and funded from Committee approved budgets.

Lifesaving and leadership courses and conferences

- Official endorsed SLSA, LSV or ILS courses and conferences for developing members and their lifesaving skills
- Other ad-hoc courses related to lifesaving and leadership may be considered on a case-by-case basis in special circumstances if funds are available or directed to the Gary Tierney Foundation

Advanced lifesaving award courses

- Any lifesaving award above the Bronze Medalion level. For example, ART, First Aid, IRB, Silver Medalion, Gold Medalion, Beach Management, Patrol Captain etc.
- Does not include "camp" costs for Bronze or SRC

Craft Subsidy - Members purchasing new or used Racing Mal and/or Surf Skis for competition

- Up to 50% for a used craft (provided the price is approximately half the cost of a new craft
 - An obligation to accept existing Club stock if there is a good match for weight and body type
- Up to 30% for a new or near new craft
- Competitors with a track record of at least 3 years regular training and competition on the chosen craft will be considered for a 30-50% subsidy on a new or near new craft
- A second subsidy on the same craft type will be considered provided all responsibilities of the first subsidy have been consistently met

Interstate Championship competition participation

- Competitors with their competition rights at Point Leo SLSC and competing for Point Leo SLSC at the Australian Championships, including Summer, IRB and Pool events
- Officials, Club coaches and team managers appointed to roles at the Australian Championships, including Summer, IRB and Pool events may also apply for a subsidy
- In addition to the subsidy provided to eligible members for the Australian Championships, the Committee will also provide funds to cover
 - o Transport of competition equipment (trailer and/or container as required)
 - Capped reimbursement (up to \$150 per night) for overnight accommodation for club members driving
 the trailers will be provided for a maximum of two (2) night in each direction for Gold Coast and the
 Sunshine Coast. Additional arrangements will be made for Western Australia or if the Australian
 Championship are being held in another location
 - At least one social event (generally a Club dinner excluding alcohol) will be provided for all competitors and helpers during the Australian Championships. The SDSC will allocate a budget

Club endorsed events held in other states

The Senior Team Manager, Head Coach and/or Boat Captain must recommend events prior to the start of the competition season (generally October of each year) to the Club Committee for approval that would be eligible for a subsidy, up to a maximum of two events per section.

This subsidy does not include support for individuals competing at "normal" carnivals held in other states.

The SDSC will consider applications for support for World Titles on a case-by-case basis.

State or National surf lifesaving teams

- Athletes, Coaches or Team Management roles selected to represent Victoria or Australia in all disciplines and age group of lifesaving sports.
- Includes state or national selection in development teams.

Subsidy criteria and expectations

- Subsidy <u>criteria</u> need to be met upon application and evidence provided by the member
- Subsidy expectations are behaviours expected by the member once the subsidy has been approved
- There are criteria/expectations "common" to all subsidies across the club and criteria/expectations "specific" to individual subsidies
- Members can apply for a special exemption to the criteria (no later than 21 days prior to the start of any event related to the subsidy) which will be determined by the Subsidy Distribution Sub-Committee
- The Subsidy Distribution Sub-Committee shall have discretion to waive eligibility requirements. The Chair must identify any criteria that have been waived when making a recommendation to the Club Committee

Subsidy application and approval process

The Subsidy Distribution Sub-Committee will circulate information about various subsidies at least annually at the start of the season via Club communication channels that can include but are not limited to the Club email and Team App.

Each section lead on the SDSC is required to work with other relevant Club members to review nominations and make recommendations to the SDSC on eligibility and compliance with expected behaviours.

For example, the Chief Instructor must collect input from the club trainers and assessors, and the Senior Team Manager must collect input from the Head Coach, Coaching Panel and/or Boat Captain.

The Subsidy Distribution Sub-Committee will make a recommendation by majority vote and submit to the Club Committee for determination.

Cut off dates to apply for specific subsidies will be circulated to all members.

To apply for the subsidy members:

- Must complete all sections of the form (available on the club website and Team App documents) and email a copy to the Point Leo Subsidy Distribution Sub-Committee
- The section lead on the SDSC consult with relevant stakeholders Club Members
- The Subsidy Distribution Sub-Committee requires 7 days to reach a recommendation by majority and will then submit this to the Club Committee for determination at the next available meeting (noting that this must be submitted 7 days before the date of the Committee meeting)
- For subsidy submissions with a deadline the timelines for review and decision will be included in the advertisement of the specific subsidy
- The section lead from the SDSC will notify the member by email of the application outcome with required actions within 7 days of the Club Committee meeting
- The Club Treasurer will arrange payment of the subsidy
